California Baby Surrogacy (CBS) is a full-service gestational surrogacy and third-party reproduction agency based in Los Angeles. For more than 12 years we have walked alongside intended parents from across the United States and around the world — over 2,000 families to date, across four continents.

Our team is multicultural by design. We work in English, Mandarin, Cantonese, and Spanish — not as marketing copy, but as the day-to-day language of clinical coordination, legal review, and emotional support. Every case is handled by a senior coordinator who stays with you from first call to homecoming.

California Baby Surrogacy (加州宝贝代孕, CBS) 是位于洛杉矶的全方位妊娠代孕及第三方辅助生殖机构。十二年多以来，我们陪伴来自美国本土及全球各地的意向父母——至今已服务超过 2,000 个家庭，遍及四大洲。

我们是一支真正多语种的团队，以英文、普通话、廣東話和西班牙语展开日常工作——不是营销口号，而是真实贯穿于医疗协调、法律审阅与情感支持每一个环节。每一个案件都由一位资深协调员从首次通话陪伴至接娃回家。

A three-step framework, fully managed.

三步式框架，全程托管。

1. Intake & match — a 30-minute free consultation in your language, followed by a personalized plan covering surrogate search, egg/sperm donor (if needed), and California-based IVF clinic selection.
2. Legal & medical — independent legal counsel for both parties under California Family Code §7960-7962, full surrogate medical screening, escrow setup, and embryo transfer coordination.
3. Pregnancy & birth — 24/7 coordinator support, monthly check-ins, hospital birth plan, parentage order, U.S. birth certificate, and travel-document support for international families.

1. 接洽与匹配——30 分钟免费多语咨询，随后产出量身定制方案，涵盖代孕妈妈寻找、捐卵/捐精（如需）以及加州 IVF 诊所对接。

2. 法律与医疗——双方独立法律顾问（依加州家庭法 § 7960-7962）、代孕妈妈完整医学筛查、信托资金账户开立、胚胎移植协调。

3. 妊娠与分娩——24/7 协调员支持、每月跟进、医院分娩计划、亲权令、美国出生证明，以及国际家庭的旅行证件协助。

TIMELINE · 时间线

A typical journey: 18 to 24 months end to end.

典型旅程：18 至 24 个月，端到端。

Months 1 to 3 — Onboarding, contracts, surrogate match. Months 3 to 6 — Medical screening, embryo transfer preparation. Month 6 onward — Confirmed pregnancy and roughly 40 weeks of prenatal care. Final 2 weeks — Travel to California for birth, parentage order, and U.S. passport.

Individual circumstances vary. International cases that require donor selection or LGBTQ+ family planning may extend by 2 to 4 months. Most families travel to California only once or twice during the journey.

第 1 至 3 月——接洽、签约、代孕妈妈匹配。第 3 至 6 月——医学筛查、胚胎移植准备。第 6 月起——确认怀孕及约 40 周产前护理。最后 2 周——赴加州迎接分娩、办理亲权令与美国护照。

每个家庭的情况略有不同。涉及捐赠者选择或 LGBTQ+ 家庭规划的国际案件可能延长 2 至 4 个月。多数家庭整个旅程仅需赴加州 1 至 2 次。

INVESTMENT · 投入预算

Typical total cost: USD \$170,000 to \$230,000.

典型项目总投入：17 万至 23 万美元。

Included: agency case management, surrogate compensation and benefits, surrogate medical and life insurance, legal fees (both sides), escrow administration, IVF clinic fees (transfer cycle), psychological screening, and 24/7 coordinator support through birth.

Not included: egg or sperm donor fees if applicable (typical add-on \$25K to \$45K), additional embryo transfer cycles if needed, and international travel and lodging. A detailed personalized estimate is provided at the consultation — no obligation.

已包含：机构全程案件管理、代孕妈妈补偿与福利、代孕妈妈医疗与人寿保险、双方法律费用、信托账户管理、IVF 诊所费用（移植周期）、心理筛查，以及全程 24/7 协调员支持直至分娩。

未包含：如需捐卵/捐精，约 2.5 万至 4.5 万美元；额外胚胎移植周期（如需要）；国际旅行与住宿费用。我们会在初次咨询时提供您专属的详细估算——无任何承诺压力。

Three things we take seriously.

Multilingual care — real working fluency in English, Mandarin, Spanish, and Cantonese across medical, legal, and emotional conversations. Not machine translation, not "someone who studied abroad."

California legal jurisdiction — Family Code §7960-7962 is the strongest gestational-surrogacy framework in the United States, recognized for same-sex parents, single parents, and international families alike.

Single-case ownership — one senior coordinator from intake through birth. No call-center handoffs. We deliberately keep caseloads small so nothing falls between the cracks.

加州法律辖区——加州家庭法 § 7960-7962 是全美最成熟的妊娠代孕法律框架，对同性父母、单亲父母及国际家庭一视同仁。

单一案件归属——一位资深协调员从接洽陪伴至分娩。不在客服中心间转手。我们刻意控制人均案件量，确保每一处细节都不被遗漏。
